## Maui County Public Health Emergency Rules Fairmont Kea Lani

Below are some important reminders in which we need your cooperation in adhering to our local government and health authorities' policies enacted to halt the spread of COVID-19.

**Mask Mandate**: Fairmont Kea Lani follows the Statewide Mask Mandate requiring all guests, colleagues and resort visitors to wear a face mask covering the nose and mouth while in all <u>indoor</u> spaces. While indoors, masks can temporarily be removed while actively eating or drinking.

• Masks will also be required in buffet and bar lines at Banquet Events, both indoor and outdoor.

## Requirements for Indoor Banquet Events, Restaurants, Spa Treatments and Gyms: As a

commercial event operator, Fairmont Kea Lani must ensure that all participants within an <u>indoor</u> public space are compliant with <u>either</u> of these Maui County rules.

• Provide proof of Full Vaccination \*\*booster shot required (when \*eligible\*)

## OR

- Provide proof of a negative COVID-19 test result taken within 48 hours of entry into the premises
  OR
- See \*\*Exemption\*\* noted below

## BOTH REQUIRE:

Identification bearing the same identifying information as the vaccination or negative COVID-19 test, which must be an FDA approved or FDA EUA approved molecular or antigen test. At-home tests are not accepted.

\*Note\*: effective January 24, 2022, "Eligible" for vaccination booster means that 6 months have passed since receipt of the second dose of Moderna or Pfizer or 2 months have passed since receipt of the initial single-dose Johnson & Johnson vaccine. The requirement for a booster does not apply to those who are under age 16 for Pfizer and under age 18 for Moderna.

**Willow Stream Spa:** Vaccine verification *or* negative test result **is required** for nail and spa services. Outdoor spa services **do not require** vaccination verification.

**Fitness Center:** Vaccine verification *or* negative test result **is required** to enter our Fitness Center. \*Note: masks are required within the Fitness Center. Outdoor fitness classes **do not require** vaccination verification.

**Restaurants:** Fairmont Kea Lani's restaurants and bars are designated as *outdoor dining* and vaccination verification is **not required** to enjoy these venues. However, please note that indoor restaurant dinign within Maui County, and off the hotel grounds, will require proof.

\*\*Exemption\*\* documents for people who have tested positive for COVID-19 and recovered:

- <u>Positive COVID-19 test result</u> that includes date & person's name and dated no more than 90 days out and no less than 11 days from indoor event/spa/restaurant/gym date.
- A <u>signed, Medical Provider Letter</u> dated at least 10 days after collection date of positive test result and no earlier than 14 days before event date and include:
  - a. National Identifier Pin (NPI) of provider
  - b. Statement verifying the patient is symptom free, or symptoms have resolved and s/he is cleared for travel
